



## Covid-19 sanitary protocol

### Int. 53rd ADAC Hill Climb Race Osnabrück 20–22 August 2021

#### Motorsport-Club Osnabrück e.V. im ADAC

The sanitary protocol is based on the relevant legal Covid-19 regulations of the state of Lower Saxony and the district of Osnabrück and on recommendations of the Allgemeiner Deutscher Automobil-Club (ADAC), the Deutscher Motor Sport Bund (DMSB) and the Fédération Internationale de l'Automobile (FIA).

#### 2. General

##### 2.1 Sanitary protocol and Sanitary Delegate

- The Sanitary Delegate has been appointed by MSC Osnabrück and reports to the Organising Committee. He acts as a contact person and coordinator; under his direction designated security staff monitor and enforce compliance with the sanitary protocol.
- Anyone who violates the sanitary protocol or refuses to obey the instructions of the Sanitary Delegate or the security staff may be expelled from the premises. This may include the disqualification of teams.

##### 2.2 General precautions and sanitary requirements

- During the entire event (including set-up and dismantling of the track and the event infrastructure), everyone has to maintain a distance of 1.50 m from any other person wherever possible / legally required.
- Medical face masks are mandatory everywhere on the grounds of the event. They may be removed as follows:
  - during the consumption of food and beverages when one has taken up one's place
  - by Drivers and their team members while at their own space in the service park, provided that no members of other teams, Officials or other persons are there at the time
  - by VIP guests at their seats and by spectators who have taken up their place in their respective zone
  - while eating or drinking
  - while smoking (only allowed outdoors and respecting social distancing regulations)
- Marked-off paths and social distancing markings must be observed.
- Gatherings of larger groups of people should be avoided anywhere on the event grounds.

- A negative SARS-CoV-2 test result (not older than 24 hours) must be presented to obtain access to the event grounds each time. Self-tests will not be accepted.

Rapid antigen tests are available for Participants<sup>1</sup>, VIP guests and spectators at three locations (main spectator entrance, VIP parking, finish area of the race). PCR tests are also available if required (eg for Participants from abroad).

Fully vaccinated persons (with certificate) and those recovered from Covid-19 (positive PCR test not older than 6 months or digital certificate of convalescence) do not need a negative test.

### **2.3 Contact tracing**

- No access to the grounds will be granted without individual access authorisation. There are digital access checks at all access points.
- Contact tracing takes place via the app “Luca”. All Participants, VIP guests and spectators have to use this application (on their own smartphone or via registration when accessing the event grounds). In the case of a Covid-19 infection, MSC Osnabrück will release the contact data thus collected to the public health authorities.

At all entrances to the event grounds, security guards will ensure that everyone is checked into the Luca app.

- Contact tracing during set-up and dismantling of the track and the event infrastructure is based on the deployment plans of the support teams.
- External service providers must have their own concepts for their staff.

### **2.4 Officials**

- The number of Officials is kept to the necessary minimum.
- Deputies are appointed for all key roles (eg Chairman of the Organising Committee, Clerk of the course, Organiser’s Safety Delegate). These deputies avoid personal contact with the primary role holders and take over from them if necessary (eg in case of a suspected SARS-CoV-2 infection).

### **2.5 Other precautions**

- Drivers and their team members and Officials must confirm in a self-declaration (see the sample in the Appendix) that they are currently free of symptoms typical of Covid-19 and that they comply with the regulations for entry from risk areas.
- The use of indoor spaces is avoided as far as possible. Where it is unavoidable, appropriate precautions are taken, eg max. number of people, ventilation, distance markings, partitions.
- A cleaning/disinfection plan is defined for the sanitary facilities and other points where contact is unavoidable (eg tables, door handles); the cleaning staff wear medical face masks and disposable gloves. Disinfectant dispensers are placed at strategic points.
- Closed waste bins are provided for the disposal of used paper tissues, used face masks, etc.
- Wherever possible, items such as radios, microphones, pens etc. should not be shared. Where necessary, objects are disinfected before being passed on (eg flags, fire extinguishers, shovels, brooms for marshals) or protected by replaceable plastic covers.
- External service providers (eg catering, company stands, tyre service) must have their own sanitary protocol in line with legal requirements.

<sup>1</sup> Participants are defined here as all persons (except VIP guests and spectators) who are – even temporarily – on site, in particular Drivers and their team members, Officials, marshals and support staff, emergency services and external service providers.

### **3. Access to the grounds**

- For Participants and spectators arriving from defined national or international risk areas, legal regulations regarding entry, testing and/or quarantine apply.
- Even when travelling to and from the event, Participants stay within their respective teams as far as possible and take appropriate protection measures.
- Before entering the event grounds for the first time, registration is mandatory for all Participants, VIP guests and spectators (see the Appendix for a sample information sheet).

#### **3.1 Drivers and their teams**

- Only persons who are indispensable for the running of the competition. A maximum of 5 persons are allowed per car entered for the competition (ie the Driver and max. 4 assistants).

#### **3.2 Officials, service providers, emergency services**

- In all functions the number of people deployed is kept to the minimum required. Roles are well defined.

#### **3.3 Media representatives**

- How many media representatives (including photographers) will be admitted and how freely they may move around the grounds – in compliance with social distancing regulations – will be determined in accordance with the regulations applicable at the time of the event.
- Accreditation takes place mainly online and in advance. Media representatives will be briefed on the general sanitary requirements and other regulations.
- The traditional open press conference on the Friday afternoon with Drivers, Officials, sponsor representatives and local politicians will be held outdoors, complying with social distancing regulations.
- When photographing, filming and holding interviews, social distancing regulations must be observed.

#### **3.4 Spectators**

- Spectators are allowed in five zones along the track.
- Access to the grounds only with a valid ticket and registration via the Luca app.
- Access checks at the gates ensure that the event grounds are largely closed off. Because the grounds cannot be entirely fenced off, security staff will monitor the area. The steep edge of the forest provides a certain natural barrier. Individual spectator zones are also monitored by security staff.
- Online ticket sales only (advance sale). Unlike in the past, tickets are valid only on Saturday or only on Sunday. On Friday, no spectators are officially allowed.
- Tickets are checked in using digital devices, without contact.
- Where spectators have to pass the paddock on their way from the car park to the spectator zones, barriers will be set up if necessary to ensure sufficient distance.  
  
Spectators may be permitted in parts of the paddock where social distancing can be ensured and this is compatible with legal requirements.  
  
In the paddock of the E-Mobile Cup (e-mobile tent), barriers will be installed so that sufficient distance is maintained when walking along the cars.
- Unlike in the past, spectators have no access to the pre-start area as a general rule. VIP guests may pass through it to get from the VIP area to the paddock, the passenger thrill rides etc., if necessary.

### **4. Procedure for suspected SARS-CoV-2 cases on site**

All Participants, VIP guests and spectators are informed about whom to contact if they suspect they have a SARS-CoV-2 infection while on site.

**If a SARS-CoV-2 infection is suspected**

the person in question will be

- separated
- provided with a medical face mask if necessary
- presented to the medical team (who will be equipped with the necessary personal protective equipment).



**If the suspicion cannot be dispelled,**

- the Clerk of the course, the Sanitary Delegate, the Stewards, the DMSB and, if applicable, the team concerned will be informed.
- the medical team - in coordination with the rescue coordination centre for the city and district of Osnabrück – will arrange for the person to be removed from the grounds
- all surfaces and objects with which the person concerned has been in contact will be disinfected or secured against further access

## 5. Organisational procedures

### 5.1 Time frame

The time frame of the event (including set-up and dismantling of the track and the event infrastructure) is streamlined as much as possible.

All Participants will arrive as late as possible and depart as early as possible.

### 5.2 Set-up and dismantling of the track and the event infrastructure

- Wherever possible, predefined teams are formed for the individual tasks and their schedules coordinated, under the supervision of the Organiser's Safety Delegate.
- Staff must be tested daily; self-tests with a four-eyes principle can be used for this purpose. Those who have been fully vaccinated (with certificate) and those who have recovered from Covid-19 (digital certificate of recovery or proof of a positive PCR test not older than 6 months) are exempt from the mandatory testing.

### 5.3 Paddock

- Drivers are allocated sufficiently large paddock spaces. They have to enter the dimensions of their vehicles and gazebos in the entry portal, and spaces are allocated on this basis. 4–5 support staff will be on site to assist the Drivers in taking up their spaces.
- The individual teams' gazebos must be open on the sides / well ventilated. The large marquee which hosts the paddock of the E-Mobile Cup will also be well ventilated.
- Contacts between teams should be reduced to the necessary minimum.
- Drivers and their teams may use the showers and toilets at the Borgloh Sports Centre, but access may be restricted depending on legal requirements. Regular cleaning or disinfection will be provided. For the paddock areas situated on private ground, MSC Osnabrück will coordinate the sanitary requirements with the respective owners (eg routing, sanitary facilities).
- On-site service by the Avon/Michelin tyre truck and pre-ordering are permitted. The tyre service must have its own a sanitary protocol.

## 6. Sporting competition

### 6.1 Competition Secretariat, entry procedure, administrative checking

- The Drivers submit their entries online.

By submitting their entries, the Drivers and their team members also agree to comply with the Covid-19 sanitary protocol for the event.

- As far as possible, administrative checking also takes place electronically in advance to shorten the time spent on site at the Competition Secretariat. However, Drivers have to sign their entry form in person, and the entries submitted must be checked against the Drivers actually on site.
- The Drivers should come to the administrative checking unaccompanied.
- The window of the Competition Secretariat can be set up as a counter so that Drivers do not have to enter the building for the administrative checking. Allocation of time slots also helps avoid crowding.  
The building of the Competition Secretariat may only be entered individually, wearing medical face masks.  
The staff working in the Competition Secretariat are protected by partitions. The room will be well ventilated.
- Cash payments on site will be avoided. Entry fees, prize money and travel allowances will be paid by bank transfer.

## **6.2 *Scrutineering***

- As a general rule, spot checks should be carried out at the paddock spaces of the individual cars in the paddock. There will be no central scrutineering location.
- Scrutineering of the FIA Cup cars will also take place at the paddock spaces of the individual cars.

## **6.3 *Drivers' briefing***

- Instead of an on-site briefing meeting, the necessary documentation will be sent out in advance. A Q&A video conference will be offered on the event weekend.

## **6.4 *Meetings of the Panel of Stewards and preliminary safety meeting***

- The number of meeting attendants will be reduced to the necessary minimum.
- The meeting room allows for sufficient social distancing between attendants during meetings including any hearings eg of Competitors or Drivers.
- Documents are shared digitally wherever possible.

## **6.5 *Official notice board***

- Starting and result lists, bulletins etc. are generally published online on the event's virtual notice board. Internet access on the event grounds is provided by external service providers.

## **6.6 *Timekeeping***

- Only those persons who are absolutely required will be in the timekeeping container; they will wear medical face masks. No one else has access.

## **6.7 *Speaker***

- The speakers' container is large enough for the two speakers to maintain sufficient distance. The speakers do not have to wear face masks. No one else has access.

## **6.8 *Line-up, pre-start and start***

- Only those staff with specific roles (eg directing the cars, clearing the cars for the start) will be present in the line-up, pre-start and start areas.
- Only 1 assistant may accompany each car in the line-up, pre-start and start areas.

### **6.9 Officials, marshals and intervention teams**

- Only the number of Marshals specified in the approved track specifications will be present at each marshal post. Their names and contact details will be registered beforehand.

The Marshals will be divided into teams who take turns and have no contact with each other. The leaders of the 13 marshal posts must ensure that their teams are aware of and comply with any changes in procedures.

The same applies to the intervention teams (eg towing services, DMSB intervention vehicle) and the staff in the holding paddock and in the paddock.

Approximately 7 Officials are present in the start area (Clerk of the course, Deputy Clerk of the course, Organiser's Safety Delegate, Deputy Organiser's Safety Delegate, Chief Medical Officer, a Steward and a Scrutineer).

- All Officials and Marshals will bring their own medical face masks and will be provided by the Organiser with any other required materials (disposable gloves, disinfectant, paper towels) with which to disinfect all items used by more than one person before passing them on (eg flags).
- Service providers and intervention teams provide their own protective equipment.
- If there is an accident on the track or an emergency on the event grounds, intervention teams and Officials (incl. the Clerk of the course and the Organiser's Safety Delegate) may not always be able to keep sufficient distance, but they are protected by their medical face masks and by the outdoors environment. Firefighters, medical responders and towing services also carry disposable gloves, disinfectant and paper towels.

### **6.10 Holding paddock**

- At least 3 staff will be present in the holding paddock after the finish line.
- If required to ensure sufficient space for the waiting Drivers, the number of cars per batch can be reduced so that fewer cars have to be accommodated at the same time, or the available space will be increased.
- Drivers are required to wear medical face masks while waiting to return to the paddock. They are requested to bring their own medical face masks for this purpose; otherwise, medical face masks will also be available in the holding paddock.
- Legal regulations for the catering industry apply for the provision of beverages to the Drivers waiting to return to the paddock.

### **6.11 Prize-giving ceremony**

- The customary large prize-giving ceremony in the marquee will be replaced by an individual presentation of cups outdoors in compliance with social distancing regulations. Whether spectators are allowed to be present will depend on the legal regulations in force at the time.

### **6.12 End of the competition**

- The usual welcoming of returning Drivers by Officials and cheerleaders after the end of the race will not take place this year.

## **7. Catering and entertainment programme**

### **7.1 Outdoor catering (for VIP guests)**

- Regarding the outdoor catering for VIP guests, legal requirements for the catering industry apply.
- Arrangements are made in consultation with the authorities to ensure compliance with the applicable regulations on social distancing and sanitary requirements. This includes a larger number of security staff monitoring compliance.

## **7.2 Other catering stands**

- Catering stands in the spectator zones and in the paddock will be operated in accordance with legal regulations.

## **7.3 Demonstration runs and parades**

- Demonstration runs and parades without passengers (usually between practice or race runs) are possible.

## **7.4 Passenger thrill rides**

- Passenger thrill rides (usually between practice or race runs) are possible. Drivers and passengers will wear their own gloves or disposable gloves, respectively, as well as medical face masks and helmets with visors. Shared helmets will be wiped with disinfectant after each use.

## **7.5 Presentation stands of external companies in the spectator area**

- Sale or free distribution of merchandising articles or other products as well as exhibitions and presentations (eg by car dealers) are generally possible and will be subject to social distancing and sanitary regulations applicable for the retail trade.

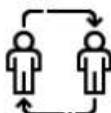
